Community Standards WECA Board Meeting recorded 10/26/11	<u><b>Curb Appeal / Grass Lawn</b></u> <ul style="list-style-type: none"> <li>▪ <b>Yards should be Edged and Mowed</b></li> <li>▪ <b>No Grass taller than 5 inches.</b></li> <li>▪ <b>Weed control at all times by appropriate means.</b></li> <li>▪ <b>Grass and Weed clippings shall be REMOVED from the street, sidewalks and driveway by appropriate means</b></li> <li>▪ <b>Sidewalks and road in front of property should be kept free of weeds, grass, trash and dirt.</b></li> <li>▪ <b>Tree and shrubbery shall be maintained.</b></li> <li>▪ <b>Tree limbs shall be cut so to allow walking on sidewalk.</b></li> <li>▪ <b>Shrubbery shall not obstruct view of windows.</b></li> </ul>	10/26/11	10 days from written notice

Community Standards WECA Board Meeting recorded 10/26/11	<b><u>Exterior of House</u></b> <ul style="list-style-type: none"><li>▪ <b>Mold and/or Mud shall be removed from the side of houses.</b></li><li>▪ <b>Fences must be approved and maintained.</b></li><li>▪ <b>Fence Gates shall be maintained and closed when not in use.</b></li><li>▪ <b>Mail boxes shall be uniform in color and appearance with the house numbers on the post.</b></li><li>▪ <b>Front porches shall be maintained, free of firewood.</b></li><li>▪ <b>Children and Adult playthings and pools, etc., shall be removed and stored out of sight by the end of the day.</b></li></ul>	10/26/11	10 days from written notice
